

NAERS™ UPGRADE QUICK REFERENCE GUIDE

Overview:

This quick guide will help you understand how to use the new NAERS™. While the new system looks different, it functions nearly identically to the former system and is designed to be very intuitive.

The new NAERS™ offers a brand-new user interface with simplified navigation that reduces buttons, eliminates redundancies, and cuts user data entry time by 60%.

Here are a few more highlights of the new system:

- Dashboard that allows users to quickly access needed functions such as “Add Product,” “Add Adverse Event,” “AE Attest,” and “Update Usage Data”
- “Submit Feedback” button on every page
- Clickable alerts which indicate compliance status, and allow users to quickly address compliance issues
- Ability to submit multiple file types when uploading labels (.doc, .pdf, .jpg, .png, etc.)
- Mobile mode, which allows users to easily enter data on the go via their mobile device
- API (Application Programming Interface) technology, which allows users to upload data from the back end using various file formats. (If you are interested in this, please contact Ryan Cargo at 760-751-3360 x2.)

Dashboard:

The new dashboard is designed to ensure any NASC member can quickly access the most-used functions of NAERS™. As you can see, across the top there are four buttons to choose from. The first three buttons, “Add Product,” “Add Adverse Event,” and “AE Attest” function identically to the old NAERS™. These should be self-explanatory, but the visuals will be slightly different due to the new user interface.

The last button, “Update Usage Data,” is a change from the old system. When you click “Update Usage Data,” any signed and finalized products missing usage data will show up in a single master list that will display all products and years, allowing you to update all usage data at one time rather than having to click the “Edit” button on each individual product. This significantly reduces the amount of time it takes to update usage data. Lastly, there are status alerts which allow you to address compliance issues quickly. You will find some highlights noted below.

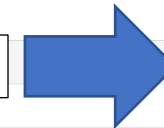
